

Active Shooter TTX Answer Key – Summer 2016

1. US government agencies—including the White House, US Department of Justice/FBI, US Department of Education, and US Department of Homeland Security/Federal Emergency Management Agency—define active shooter as “an individual actively engaged in killing or attempting to kill people in a confined and populated area.” Implicit in this definition is that the subject’s criminal actions involve the use of firearms. In an active shooter situation, the Department of Homeland Security (DHS) recommends the following:
 - Be aware of your environment and any possible dangers;
 - Take note of the two (2) nearest exits in any facility you visit;
 - If you are in an office, stay there and secure the door;
 - If you are in a hallway, get into a room and secure the door; and
 - As a last resort, attempt to take the active shooter down. When the shooter is at close range and you cannot flee, your chance of survival is much greater if you try to incapacitate him/her; and
 - Call 911 when it is safe to do so!

2. “Run,” “Hide,” and “Fight” are the actions that both the Federal Bureau of Investigation (FBI) and US Department of Homeland Security (DHS) recommends in an active shooter situation. Each action is explained in further detail below:

Run:

If there is an accessible path, attempt to evacuate the premises. Be sure to:

- Have an escape route and plan in mind;
- Evacuate regardless of whether others agree to follow;
- Leave your belongings behind;
- Help others escape, if possible;
- Prevent individuals from entering an area where the active shooter may be;
- Keep your hands visible;
- Follow the instructions of any police officers;
- Do not attempt to move wounded people; and
- Call 911 when you are safe.

Hide:

If evacuation is not possible, find a place to hide where the active shooter is less likely to find you. Your hiding place should:

- Be out of the active shooter's view;
- Provide protection if shots are fired in your direction (i.e., an office with a closed and locked door); and
- Not trap you or restrict your options for movement.

To prevent an active shooter from entering your hiding place:

- Lock the door; and
- Blockade the door with heavy furniture.

If the active shooter is nearby:

- Lock the door;
- Silence your cell phone and/or pager;
- Turn off any source of noise (i.e., radios, televisions);
- Hide behind large items (i.e., cabinets, desks); and
- Remain quiet.

If evacuation and hiding out are not possible:

- Remain calm;
- Dial 911, if possible, to alert police to the active shooter's location;
- If you cannot speak, leave the line open and allow the dispatcher to listen.

Fight

As a last resort, and only when your life is in imminent danger, attempt to disrupt and/or incapacitate the active shooter by:

- Acting as aggressively as possible against him/her;
- Throwing items and improvising weapons;
- Yelling; and
- Committing to your actions.

Note: If there is more than one (1) Active Shooter and/or if the Active Shooter has additional weapons aside from only a gun, the Run, Hide, and Fight method still applies. You must apply the most appropriate method when in a particular situation.

3. Remaining silent in an active shooter situation is of critical importance and one way to accomplish this is to shut off or put your mobile device on mute. While turning off or putting your cell phone on mute varies slightly by manufacturer, you should take a moment to familiarize yourself with this process and then practice it to ensure that it can be done quickly.
4. Try to memorize at least one (1) or two (2) phone numbers of family members or loved ones in case your cell phone is lost or damaged in this situation. In addition, establish a family communications plan which may be found by following this link:

5. The phrase, “If you see something, say something,” is used throughout the Nation. The Department of Homeland Security (DHS) defines suspicious behavior as any observed behavior that could indicate terrorism or terrorism-related crime. This includes, but is not limited to:
 - **Unusual items or situations:** A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.
 - **Eliciting Information:** A person questions individuals at a level beyond curiosity about a building’s purpose, operations, security procedures and/or personnel, shift changes, etc...
 - **Observation/Surveillance:** Someone pays unusual attention to facilities or buildings beyond a casual or professional interest. This includes extended loitering without explanation (particularly in concealed locations); unusual, repeated, and/or prolonged observation of a building (e.g., with binoculars or video camera); taking notes or measurements; counting paces; sketching floor plans, etc...
